



The purpose of the sessions is to help your child learn some textiles skills through half termly projects. The project each half term will change to cover a different technique involving textiles and will include both design and creation. These techniques will involve the use of tools that will need care and attention in order to avoid injury, such as pins, needles, scissors, etc.

The club is designed to be a relaxed and social space, so appropriate background music may be played and light snacks (e.g. biscuits, grapes, etc) will be provided, so if your child has any allergies, please ensure these are noted on the registration form.

Please send your child with just a water bottle. Please avoid sending them with anything else unless it is absolutely necessary. Children arriving on their own straight from school can of course bring their school bag, which will be stored safely during the club.

The session begins and ends at the time agreed, regardless of when your child turns up/leaves, unless prior agreement has been made to amend the start and end time.

The club is provided on a half-termly commitment. Therefore, payment for the half-term should be made in full up-front. If this is problematic, please discuss with me, as a payment plan may be possible to arrange.

If your child is unable to attend a session, please let me know ahead of the start time (see contact details at end of agreement), in order to avoid me needing to worry or call you in their absence. Please do not send your child if they are not well enough to participate in the club activities for any reason.

I will do everything in my power to ensure a safe environment and safe use of all equipment and tools but cannot be held responsible for any injuries sustained by children who do not follow any instructions given when it comes to this – please see the attached waiver you will need to agree to and sign, in order for your child to join the club.

Please note that my husband (or other responsible adult) and our twin daughters may be in the house at the time of the sessions. My husband is an ex-school governor and holds a clean DBS check, as do I. He will be helping to welcome you and your child when you arrive and leave.

There will not be enough space for parents to stay and help their child during the club, however if you need to remain close by for any reason, please discuss this with me as we may be able to accommodate you in another space.

By signing this agreement, you acknowledge and agree to comply with the above and you confirm your child wants to do the club and wants to engage in the sessions.

## TEXTILES CLUB WAIVER

In order to keep all persons safe and covered, we ask for you to complete the waiver before joining the club. You must be the parent, legal guardian or Responsible Adult (as defined below) of that person in order to sign the waiver. This is a legally binding document. Do not sign unless you wish to be bound by its terms.

**I hereby acknowledge and agree to the following:**

1. I am a competent adult aged 18 years or older.
2. In so far as this waiver and release of liability agreement ("agreement") is signed by me on behalf of a child who is under the age of 18 years ("child"), I confirm the child's full name and age are printed above and that either (i) I am the parent/guardian of that child; or (ii) where I am not the parent/guardian of that child I certify that the child's parent(s) or guardian(s) (as the case may be) of that child has/have granted permission for me to assume responsibility for that child ("Responsible Adult") and for me to have the right to sign this agreement on their behalf.
3. I acknowledge that this agreement will be used by Mrs Leanne Gulvin and will govern mine and the child's actions and responsibilities whilst participating in the activities of the club.
4. The child's involvement and/or participation in the activities is voluntary, and I am acting under my own free will (on behalf of the child in my capacity as parent, guardian or Responsible Adult, as applicable).
5. I acknowledge that my/the child's participation in the activities may be physically demanding and that the risk of injury from the activities may happen. I also acknowledge that such risks cannot be eliminated entirely without jeopardizing the essential qualities of the activities and that while particular rules, equipment and self-discipline may reduce the risks, the risk of injury does still exist.
6. To reduce the risks, I agree (on behalf of the child as parent, guardian or Responsible Adult, as applicable) to follow (and, if applicable, procure that the child follows) the rules established for participation in the activities.
7. I confirm that I have read (and/or have had read to me), understand and will follow (and, if applicable, procure that the child follows) the rules established for participation in the activities and the reasonable instructions given to me before and during the club.
8. I certify that the child has no medical conditions or health concerns that make it dangerous to participate in the activities in a safe manner for themselves or others and that if I have any concerns in this regard, Mrs Leanne Gulvin has been informed or will be informed prior to my/the child undertaking any of the activities.
9. Mrs Leanne Gulvin will only accept liability for any loss or damage the child may suffer undertaking the activities or otherwise if that loss or damage is caused by Mrs Leanne Gulvin's failure to carry out her obligations under this agreement.
10. I consent to for the child to receive treatment that may be deemed advisable in the event of injury, accident, and/or illness as a result of my/the child participating in the activities.
11. I agree that entering into this agreement indicates permanent waiver and release of liability with respect to myself and the child. I understand that this agreement will be kept on file for future visits. I understand that if I wish to revoke this agreement I must contact Mrs Leanne Gulvin and obtain their agreement to such revocation in writing.
12. I understand that this waiver and release of liability is intended to be as broad and inclusive as permitted by the laws of England and Wales (with respect to myself and the child). I further agree that if any part/s of this agreement are held invalid the remainder will continue in full force and effect.

I CERTIFY THAT I HAVE READ THIS DOCUMENT AND FULLY UNDERSTAND ITS CONTENT AND ACCEPT THE WAIVER TERMS AND CONDITIONS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT AND I SIGN IT ON MY OWN FREE WILL.
